In 2010, Save the Waves launched a Chile relief operation in response to the February 2010 Chile earthquake and tsunami, and distributed essential relief supplies to thousands of Chileans in remote coastal areas, as well as initiated and funded community development projects in coastal communities to help Chileans get back on their feet. The organization also dedicated and implemented the first World Surfing Reserve in Malibu, California, and established a pipeline for future reserves in Australia, Portugal, and California. Save The Waves also initiated or continued campaigns to protect surfing areas in California, Chile, Costa Rica, Ireland, and Peru.
