In 2011, Save the Waves implemented the second World Surfing Reserve in Ericeira, Portugal, to proactively protect coastal resources in the area. The organization also continued its flagship Clean Water Chile Program, fighting against industrial water pollution in central Chile. Our Endangered Waves Program has had several significant victories. We provided support to a number of campaigns around the world including Doolin Point and Crab Island in Ireland, Playa Encuentro in the Dominican Republic, and Molle in Sweden. Finally, our environmental coalition celebrated a major victory late in the year when plans for a proposed tuna farm just off the coast of Pavones, Costa Rica - a world class left point - was halted, sparing the area's water from extensive pollution.

For the past several decades, the waves at South Sloat, Ocean Beach in San Francisco have been eroding the cliffs, where the highway, adjacent parking lots and sewage infrastructure were built too close to the coast. The City of San Francisco has continued to dump massive boulders on the beach to armor the bluffs and temporarily protect city infrastructure, which has worsened erosion over time, threatened the epic beachbreak at South Sloat, destroyed habitat for local wildlife, and trashed the beach with artificially placed rock and debris. Save The Waves launched the Save Sloat! campaign to demand that the City of San Francisco implement an environmentally sustainable solution, including adopting a strategy of "managed retreat" or "strategic relocation" to move or abandon threatened infrastructure and restore the sandy bluffs and nearby beach. Our campaign celebrated the unanimous denial of a City of San Francisco permit for more coastal armoring at Ocean Beach.
